People watching the real estate market closely in 2013 have seen small signs of a slow recovery, Repp noted.

In brief, IDAs offer various benefits to businesses looking to facilitate economic development through the purchase or development of real estate. The benefit here come from the fact that real property owned or controlled by IDAs is exempt from property and mortgage recording taxes. These exemptions can be passed through to businesses occupying





the land."

"As an additional benefit, purchases, such as the purchase of manufacturing equipment in connection with expanding the business and related to IDA project, can be exempt from state and local sales taxes," Repp noted. "This is a win/win as it incentivizes business owners to expand their companies by providing significant tax saving and at the same time the local economy benefits by the emergence of new business and creation of new jobs."

As the market continues its upward trend the firm expects to see more and more businesses taking advantage of this real estate investment opportunity, Repp noted.
