"Some of us were lucky enough to suffer only minor damages with a few downed trees or damaged fences," she said. "Others have had their businesses, homes and belongings washed away. Now is the time to sit down and think: What can we do differently to prevent tragedy and minimize loss in the future?

Repp lists several tips for residential and commercial property owners to take in preparation for future storms, including; Take time now to review your insurance policies and update them to ensure that you have adequate and proper coverage in place; keep copies of all important



documents such as leases, deeds, financial documents and insurance policies in a safe deposit box or other secure place away from originals; take photos of personal property and keep receipts and serial numbers for important, irreplaceable or expensive items; and have a system in place for computer back up, cloud or offsite storage of records, and if you are a business owner, a system to contact employees, clients and colleagues if business is closed.

"The key here is to be proactive so that you won't need to be reactive," Repp said. "Taking simple steps such as these can help us as a community to be better prepared for the unpredictability of Mother Nature." Repp earned a bachelor's degree in political science, magna cum laude, from East Carolina University. Upon graduation, she received a merit scholarship to attend Jacob D. Fuchsberg Touro Law Center. While attending law school, she volunteered with the not-for-profit organization of SEPA Mujer and Nassau/Suffolk Law Services and interned with the Suffolk County Attorney's Office.
